Grants were given to Beautiful Gate Handicapped Peoples Center in Jos, Nigeria. The 60 employees in the shop built 2848 tricycle-type hand-pedaled wheelchairs which were donated to polio survivors. They also gave out 64 regular wheelchairs, 184 walkers and walking sticks, 183 pairs of crutches and 40 white canes to the blind. They gave many sacks of beans, rice and other foodstuffs to the 350 students at the Plateau School for the Deaf.

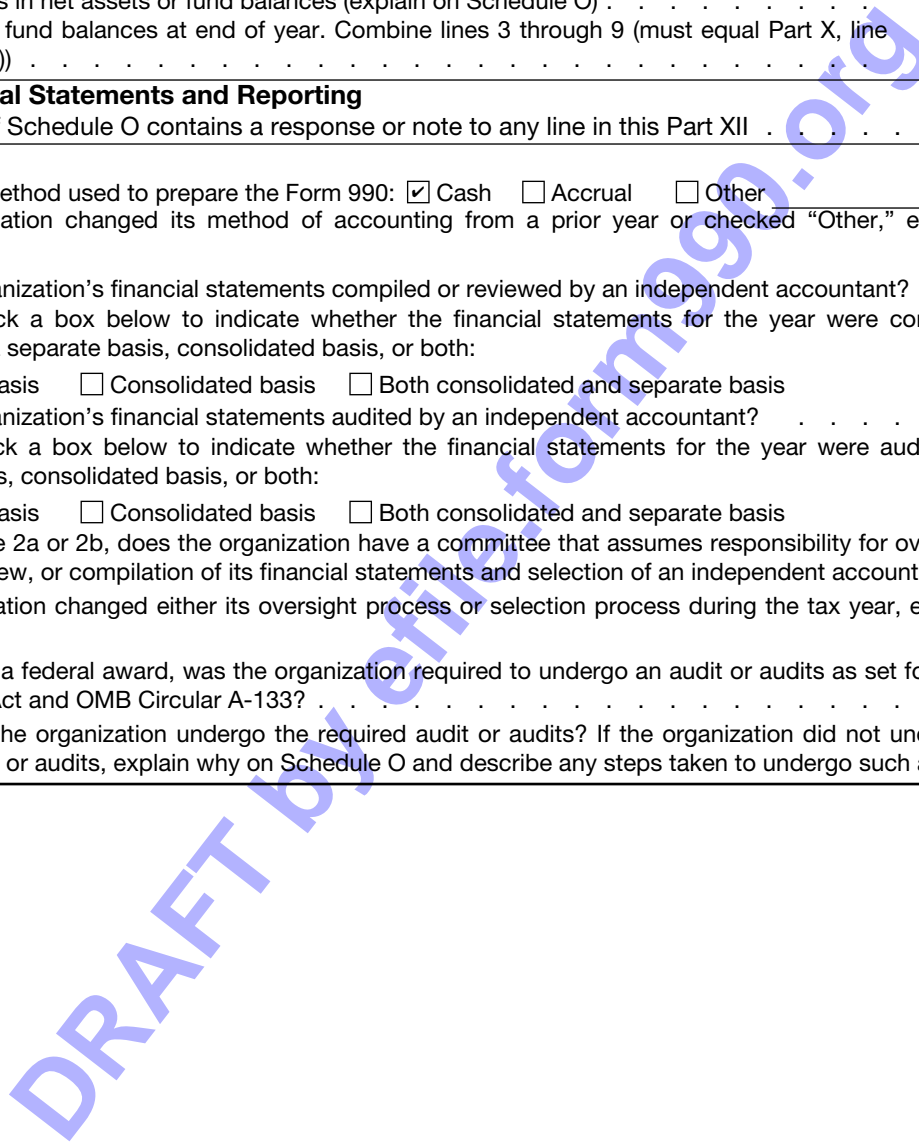
