

The president of Wheelchairs for Nigeria makes one or two trips every year to Jos, Nigeria where he inspects the wheelchair shop and travels with the director of Beautiful Gate Handicapped People Center to assist with the distribution of hundreds of wheelchairs. The treasurer, Carol Watson CPA, makes an annual trip to Nigeria to oversee the Beautiful Gate bookkeeper and do an inventory of all supplies and equipment in the shop. The accountant with World Renew, an arm of the Christian Reformed Church, who is a major mission agency in Nigeria and also contribute to Beautiful Gate, Kathy VanderKloet, who lives full-time in Jos, Nigeria, meets regularly with the Beautiful Gate bookkeeper to reconcile accounts and issue financial statements.
